



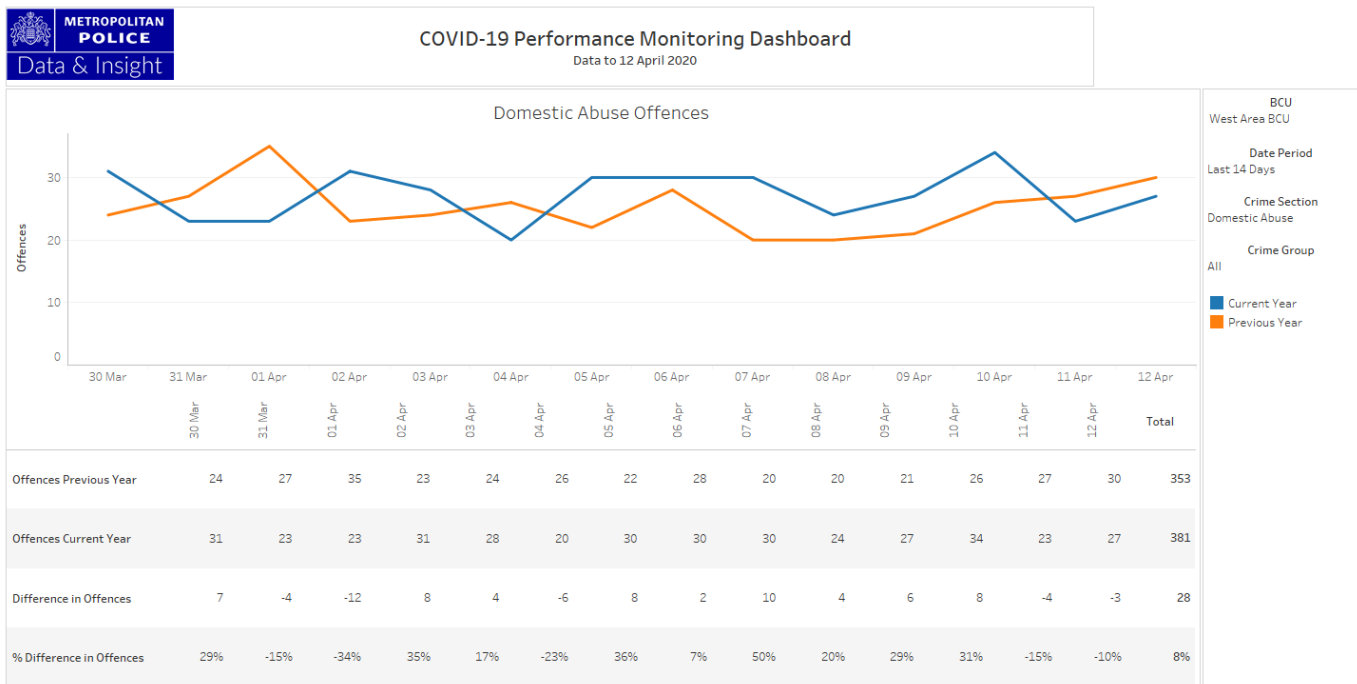
## Briefing for stakeholders 2

### 1. Recorded data

The West Area BCU (Hillingdon, Ealing and Hounslow) has seen a year-on-year increase in DA Offences (using the police data for the last 12 weeks) of 7.9% (381 recorded offences compared to 353 offences).

In the last 3 weeks there has been an increase of 1 recorded crime - 84 DA Offences from 83.

### West Area BCU:



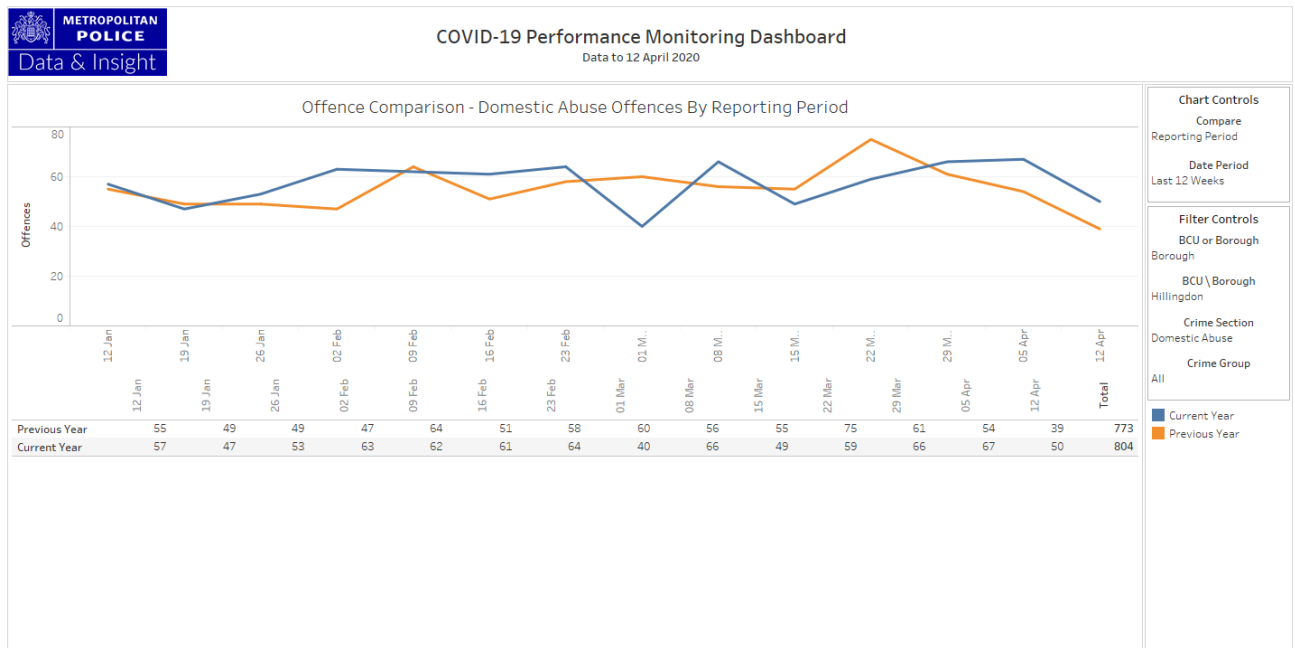
### Hillingdon Borough:

Data shows for the last 12 weeks shows an increase of 31 DA Offences compared to the same period last year (up from 773 to 804).

In the last 3 weeks there has a 17.5% increase in recorded DA offences compared to the 3 weeks before (181 recorded offences compared to 154). However, there is the start of a downward movement, which broadly tracks last year. It is too early to say whether or not this is a trend.

In addition, it is worth noting that this police data does NOT include the non-crime element, which invariably would be higher than the DA Offence data.

**Recommendation:** That the wider partnership markets and broadcasts the availability to DA support services on the borough and across London.



### Hillingdon IDVA Service

The Hillingdon IDVA Service, whose staff are operating remotely have managed an average of 15 new medium/high risk cases per week over the past 3 weeks. In the 7 days from March 30 there were 54 police MERLIN reports communicated by the police to the Multi-Agency Safeguarding Hub (MASH) relating to children and vulnerable adults exposed to DA; 47 relating to children and 7 reports for vulnerable adults. There are 26 referrals being reviewed at the MARAC meeting on April 9<sup>th</sup>.

### DA MARAC

There were 26 referrals at the last MARAC meeting on April 9<sup>th</sup>. The next MARAC meeting is on April 24<sup>th</sup>. See below for the DA MARAC Coordinator's contact details.

### Multi-Agency Safeguarding Hub (MASH)

Between 30 March and 12 April 2020 there were 99 police MERLIN reports communicated by the police to the Multi-Agency Safeguarding Hub (MASH) relating to children and vulnerable adults exposed to DA; 84 relating to children and 15 reports for vulnerable adults.

## **Helpline calls**

Funded by London Councils, Women's Aid, Refuge, the Rape and Sexual Abuse Support Centre (RASASC), the Men's Advice Line (Respect) and the Women and Girls Network (WGN) are working together to deliver dedicated helpline services for all victims of domestic and sexual violence. This service includes men, boys and LGBT callers.

In Financial Year 2019/20 Quarter 3 there were 173 callers who identified being resident in Hillingdon Borough; this is the 6<sup>th</sup> highest out of 33 borough areas in London (including the City of London). This call rate volume is the 4<sup>th</sup> highest in London when measured per 1000 of the population.

The Refuge helpline are highlighting a notable increase of calls to its helpline.

The Home Secretary has announced has £2m funding support for help lines and on line support services. This is in addition to the £750m boost for the charity sector announced by the Chancellor.

## **2. Emergency Fund to support the voluntary sector**

The Mayor of London has pledged £1 million to a new emergency support fund to help London's community and voluntary organisations affected by the impact of the coronavirus.

The Mayor has joined City Bridge Trust, the City of London Corporation's charitable funder, and London Funders, a network of investors of London's civil society, to launch the new fund – with an initial £1 million provided by City Hall and £1 million from City Bridge Trust.

### **Resources and helpline on child sexual abuse (CSA)**

The government wants to ensure that the public and professionals are aware of the resources and helplines they can access to help them prevent CSA.

There is support available through the Lucy Faithfull Foundation, such as:

- A confidential helpline (Stop It Now! – 0808 1000 900) for anyone who is concerned about their own behaviour or the behaviour of others – this can be accessed by any member of the public or by professionals who need advice on child sexual abuse risk whether they are concerned about the behaviour of an adult or someone under-18. #### **5. National Police Chief's Council (NPCC) - Crime statistic for England & Wales**

The NPCC reports that in the 4 weeks to April 12<sup>th</sup> there has been a 28% reduction in crime in England and Wales compared to the same period last year.

In the same periods there has been a 14% in 999 calls and a 13% reduction in calls to the 101 non-emergency number.

**There is no mention of domestic abuse in the press release.**

There have been reductions in recorded cases of serious violence / robbery / residential burglary / Motor Vehicle Crime, Shoplifting and Rape.
